- 2. Rates quoted are GST exclusive. GST does not apply to NDIS rates but may apply to other rates. Services purchased by another organisation will generally attract GST.
- 3. Prices will be reviewed 1 July 2025, or earlier if changes are made to the NDIS Price Guide.
- 4. Rates are based on services delivered in Adelaide Metro, Riverland or Limestone Coast. Services delivered outside these areas may be charged at different rates – subject to the maximum set by the NDIS Pricing Arrangements and Price Limits.

## **Cancellation policy**

Where services are no longer required you must provide the notice as stated in the Service Agreement to cancel services.

To cancel a scheduled shift or support as much notice as possible is appreciated. The schedule below outlines the charges which may be applied in the event of any cancellation.

The NDIA Pricing Arrangements and Price Limits allow for providers to claim Short Notice Cancellations which is where you give us less than two (2) days' notice of a cancellation.

We will charge for shifts cancelled with less than two 2 days' notice if we were not able to find alternative billable work for the relevant worker and are required to pay the worker for the time that would have been spent providing the support.

If you turn a Lifestyle Attendant away when they arrive for a shift, this counts as a Short Notice Cancellation and we will charge the total value of the shift.

It is understood that emergencies may arise where a customer may not be able to notify Enhanced Lifestyles within the required period and an exemption from cancellation payments may be approved. This will be determined on a case-by-case basis by the organisation. Please see the organisation's cancellation policy for further clarification if required.
